

2. Activity Description.

On behalf of Seagreen Wind Energy Ltd, Nexans Norway Dykkerteknikk AS continues to deliver nearshore export cable protection services and diving assistance in preparation for the pull-in of three export cables

Due to recent storm damage to the three self-submersible cable protection pipes and rockbag temporary moorings, the known locations of two of the pipe ends and rockbags are shown in fig 2 and table 1.

Repair works will commence at a date to be confirmed, vessel details will be promulgated when known.

3. General Safety Advice

All vessels engaged in the nearshore protection work will exhibit appropriate lights and shapes prescribed by the International Regulations for Preventing Collisions at Sea; relative to their operations. All vessels engaged in the activity will also transmit an Automatic Identification System (AIS) message.

MARINERS ARE REMINDED to navigate with caution and keep continued watch on VHF Ch. 70/16 when navigating the area
